Cllr Wilson explained that financial reporting process:

All Standing Committee Chairmen now sit on F, P & R.

Accruals undertaken at end of financial year – not each month.

Balance Sheet – RFO advised that current practice is to transfer funds instantly between the Barclays current and active saver accounts. Transfers to the Barclays accounts from the Arbuthnot Latham call account would takes 3 days and from the notice account 100 days. The latter would also involve a notice given account. Current rates of interest: active saver account 0.19%, call account 0.05%, notice account 0.60%. Following discussion, it was agreed that it was safer to have two or more separate accounts. FSCS cover effective 30 January 2017 is £85,000 per financial institution.

Discussion: A charitable event, so deserving of a grant. The budget should assume the profit goes to the charity after all expenses have been paid, with the ticketed priced accordingly. The Parish Council should support the charity direct, if it is going to.
