Recommendation: Objection – Whilst welcoming the development of this site it is considered that the proposals are contrary to Policy DM16 of the WCC Local Plan Part 2 in that it does not respond positively to the character, appearance and variety of the local environment, within and surrounding the site, in terms of its scale (height); (in the absence of comments from a Highways consultee) contrary to Policy DM18 of the WCC Local Plan Part 2 in that it the site is not considered suitable for an HGV depot and does not provide a safe access from a small rural road with adjacent accesses to existing developments; concern raised over the cumulative effect of increased traffic in this area – 5 in favour, 1 abstention.

Resolved: To recommend to Hampshire County Council that the west section of the Lane is blocked with bollards either at Basingwell Street or the Jubilee Hall, including appropriate signage, whichever is judged most suitable on the grounds of traffic access and safety.

It should then prepare the representation.
