- The Parish Council notes the objections lodged and would ask WCC to ensure relevant authorities and professional bodies undertake the necessary tree, hedge and wildlife surveys to ensure the demolition works, if approved, do not negatively impact nature.
- WCC should also ensure the demolition works, if approved, do not adversely affect material consideration B530 and B540 to protect amenities of adjoining properties during demolition and are mindful of timings of any related works and their impact on neighbours.
- The queries on the 'uninhabitable' status of the property should be considered further by WCC, nothing that the applicant has replied to this query with the WCC Planning Officer in the Planning Statement.
- Other comments relating to possible future road junction changes are not relevant to this particular planning application.

A reminder was given that comments, based on material considerations, could only refer to the tabled planning application, not any speculative ideas for the future use of the land.
