### PH116/25 Public Session

The following points were raised:-

- Cricklemede Bus Stop Location queries arising over siting away from streetlight, bench and hard standing. Concerns over no pavement leading to the site forcing people to walk in the road rather than over unkept grassed areas. Residents were referred to the HCC report it site regarding bus stops and the Clerk would ask the HCC Transport Officer to respond to concerns.
- Locks Farm Solar Farm one member of the public reiterated concerns regarding contractors keeping to planning conditions set and raising awareness that this had been reported to WCC Enforcement Team.
- Glebe Farm Solar Farm Application one member of the public requested that the application be revisited in light of new professional reports. It was noted that the opportunity would be possible at the associated WCC Planning Committee meeting.
- Grovers Field junction onto Hoe Road concern noted over parking directly opposite junction that was causing visibility issues and creating a one lane trafficway. This was referred to making a report to HCC regarding road layout for them to reconsider.
- Basingwell Street car park uneven kerbs and pavement concern was raised after a
  pedestrian fell in the area. Councillors would survey the area and send a report to WCC
  for them to address.

The five members of the public left the meeting at this point.
