RoW Report for April 2024

Footpath 12: Concern was raised in 2021 by the landowner of the field behind 'Deer Park' when the developer erected a permissive path sign at Coppice Hill and created access from the housing development onto the Right of Way. The Parish Council was to approach Bargate to come to an agreement with the landowner to negotiate a way to achieve access. The outcome of this is not known or, in fact, whether contact was made. The landowner is now planning to keep horses in the field and, if they do, they may wish to close the access.


Footpath 2 and 1: I and two other path wardens looked at the section of Footpath 2 at Cricklemede which is used by children walking to school but which has become muddy at its lowest point with grass encroaching from the sides. Because the surface of the path is laid with compacted noggin (a type of gravel), we found we were unable to dig into the surface to remove the grass and mud. We concluded that a contractor would be required to remedy the problem. Thanks go to the Executive Officer's husband for clearing the side vegetation on Footpath 1, Green Lane. This well-used path is now easier to walk.

We have yet another new volunteer path warden bring our total to 8. I have emailed an HCC engagement officer for information about training courses that our new wardens could attend even if they are further away from our area. Our volunteers are keen to attend.

Footpath 43: Southampton Ramblers have sent their donation of £600 to the Parish Council for the third kissing gate to be installed at Park Lug at the boundary with Durley. I have written a letter of thanks to them. Some of their members will be helping the Waltham Ramblers volunteers to install the gates when the ground is in a suitable condition.

A member of the public spoke to highlight concerns of traders in the high street regarding the current parking situation. He felt that the atmosphere on the high street, when the traffic wardens were present, was toxic and negative. The heavy-handed approach was not conducive to visitors shopping in the town. There was a perception that customers were being lost as they could not easily park on the high street, especially when the car parks were full. There was also some confusion about the double yellow lining, particularly for blue badge holders. A suspension of the traffic warden patrols was requested to encourage drivers back to the high street. A possible change of the Lower Lane car park from long stay to short term was



also suggested, with the offer of season tickets for the Jubilee Hall car park as a long stay parking alternative. The committee acknowledged the points raised and explained that the Parish Council had been in talks with Hampshire County Council and Winchester City Council about these matters, particularly with regard to the accuracy of the line marking which, at present, was unclear in places. It was noted that additional disabled parking spaces were now available on the High Street and in the central car park. There was an emphasis from WCC to encourage drivers to park in the car parks and stay longer rather than park on the High Street for maximum 30 minutes, which would be in the interests of a variety of traders. The Committee noted points raised. The Executive Officer noted that summer promotion of the town was being considered by the Community and Environment Committee and Town Team which would hopefully encourage and increase tourism and economic interest.

The Speed Indicator Device was due to be positioned on The Hangers this week with the support from the Parish Council grounds team. With the introduction of solar panels on the posts, the units would not require such regular movement as previously. However, it was noted that the posts already existing for the SIDs, such as lamp posts, were not suitable for solar panels, which needed angling, therefore new posts would be required. The Beeches Hill post was too low for the SID plus the solar panel and the Hoe Road lamp post was leaning. A site for a new post on Botley Road had been identified, by Bishop's Lane before descending to the Crown roundabout, which would be passed to HCC for approval as a SID site. Additional training for grounds team to work on the roadside was to be investigated. The company supplying solar panels was due to be contacted for quotations for additional units. Sites at the bottom, and top, of Beeches Hill were to be used in due course. The two-week period for any one site was only HCC policy and this was due to be reviewed in Summer 2024.

Agenda Item - Footpath 12 Access - for consideration

An email correspondence has been received from R Shields, resident, in relation to a local footpath:-

When Bargate Homes had finished the development of Deer Walk, they erected a Permissive Path sign at the entrance to the estate pointing towards the other side to join with Footpath 12 (The Allan King Way). The landowner raised concerns about the assumed access across their boundary into their field.

The Parish Rights of Way Warden put the attached paper to the Planning and Highways Committee (Vice Chair Kevin Jones) on 25 May 2021. The committee resolved to approach Bargate Homes re the footpath.

At the next meeting on 15th June 2021, it is recorded that the Committee noted the response from Bargate on Footpath 12. However, the response itself is not recorded.

I was speaking with the landowner on Saturday who expressed their concerns about the public crossing their boundary. They are considering having horses in the field which will necessitate closing off the gap in the fencing which will prevent the access from Deer Walk. Since some of the residents of Deer Walk use the field to exercise their dogs, it might come as a bit of a shock to find their access is barred.

Would the Parish Council wish to take this up with the landowner, following the earlier	
agreements with Bargate?

"Deer Walk" Permissive Footpath and Footpath 12 Right of Way

Situation

At the instigation of the Parish Council the developer of the "Deer Park" estate provided a permissive pathway between the two housing developments to join Footpath 12 (King's Way). The pathway is usefully signed "Permissive Path" at the point shown on the map.

Footpath 12 runs along the north east edges of fields between the Botley Road and the B2177 opposite Anatolian Restaurant. The landowner of the field accessed from "Deer Park" has asked, through a third party, who would pay for a stile or kissing gate should he fence off his field.



Separately, the landowner has approached the Parish Council complaining about the sign leading to his land for which he has not granted access. He has now asked his Agent, Tim Gardner of Ian Judd & Partners, to help him.

It is perfectly in order for a landowner to fence in his land, provided there is access for public footpaths, but in this case the access is from private land. It seems that there were no agreements between the developer (Bargate Homes) or the landowner about access.

Suggested Way Ahead

The Parish Council approach Bargate to ask if they had any agreement with the landowner to join their permissive path to the public right of way, crossing the landowner's boundary, and, if not, gives them details of the landowner and his agent to come to an agreement about the access and the sign post.

Assuming an acceptable arrangement can be negotiated, Bargate Homes provides a kissing gate to access the landowner's field. Alternatively, Bargate fund a kissing gate which could be procured and installed by the Parish Council.

Dear All,

We are receiving many complaints from the businesses of Houchin Street who have bins roadside and are now being asked to use the new bin store facility in the car park.

They are querying how they are expected to move bins from their premises into the facility and how refuse lorries can collect from the store itself, amongst other concerns such as staff being uninsured when crossing a road to load their bin.

One business has also queried the status of the Houchin Street as they feel it is a 'service road' and not a public access road – this needs formal clarification to the businesses concerned.

We are also receiving queries from the general public (residents and visitors) about the **movement of the disabled parking bays** and **loss of two parking bays** in a needed car parking area.

We had queries about **why metal railings were installed and not wooden ones**, or why screening hasn't been installed when the driving need was for a tidy, and 'out of sight' bin store. And also the **large size of this facility** has been queried.

To date, since its installation in November/December 2023, the facility has been unused.

To this end, we would like to arrange a meeting to discuss this bin store and whether to continue with this facility, or consider other options.

Please let me know of your availability in week commencing 22nd April, or 29th April. Ideally, we'd like someone from WCC, HCC and BWPC to be in attendance.

With regards to how do they move bins to the facility, some firms use collapsable trolleys, some just carry the bags, some use vehicles, it's up to them, but for the vast majority, it is only a very short distance from there the bins are already stored, and certainly a shorter distance than firms in Winchester have to navigate with their bins. I know some people complain about the weight of the bags, or the bags splitting, in that case the answer is to not load the bags so much.

How can refuse lorries collect the bins? The same as they do now, park in Houchin street and move the bin to the lorry, it's no different to existing, and this was checked with them before we built it.

Staff being uninsured to cross the road - The bins are already in the road, that's why HCC are asking them to be moved, and they are there without permission so where they are now is most definitely uninsured. I'd also be very surprised if staff aren't insured to cross a road, going to a shop, deliveries, going to the bank, the post office, being out and about in the public realm is a normal business activity.

Houchin Street is most definitely not a service road, it is a public highway, if it wasn't, HCC wouldn't have any legal authority to issue the letters, there are also double yellow lines, public access to the car park etc, if it most definitely not a 'service' road.

The replacement disabled bays have now been provided, but there is a possibility of more as we haven't yet met the 6% recommended minimum number, but this is subject to a more senior decision policy making process.

Metal railings – I'm unsure, I was under the impression they were going to be wooden but the previous officer decided on metal railings, I'm unsure why as he's now left, he certainly provided wood elsewhere at every other site he provided, so it would have been for a good reason, plus the store is screened by the brick wall to one side.

The facility is the size it is because there needs to be manoeuvring space within the compound for the waste firms to locate and extract their particular bin.

The site has been unused as firms have declined to use it, which was disappointing as it was provided to improve the appearance of the town and make it more attractive and safer for visitors, from below it would appear that HCC are now requiring firms to use it as storing private property on the highway is not permitted, so no doubt very shortly it will start being used. Firms do of course have the option of storing waste within their own premises if the road is not permitted and they do not want to use the bin store.

Obviously I'm happy to come out and have a chat if you want me to, please just let me know, but as most questions had immediate answers a quick reply seemed expeditious rather than having a large meeting.

I am writing to all of the businesses in our town with regards the newly installed bin storage area located in the long stay car park and Houchin Street.

All businesses, if they have not already, will be receiving a letter from Hampshire County Council informing you that your bins, that currently reside conveniently at the rear of your premises must be moved into the new bin storage area in the car park.

This will be in the form of a generic letter saying that your bins are causing an unauthorised obstruction and accompanied with a photo.

As well being an inconvenience, I and other businesses have concerns for the welfare of our employees having to walk the distance with heavy bags of waste taking into consideration the traffic situations, weather conditions and that of our staff not being covered by company insurance whilst off premises, we feel that it is not practical nor required.

We also feel that this bin area will be unsightly & a potentially smelly area outside of the Social Club, a potential invitation for vermin such as rats, with the possibility it may be used for fly tipping and to boot reduces much needed parking spaces in the town by 4 spaces.

With this in mind I am asking for your support with overturning H.H.C.'s decision to require us to use this new bin storage area, if not for the fact that for decades there has been no need to such an area with no known issues about the current bin locations.

For this I ask that each business write an email to Nick Adams-King (nick.adams-king@hants.gov.uk) and Patrick Blogg (Patrick.blogg@hants.gov.uk) stating that you do not wish to use the new bin storage area and your reasoning for your decision.

Further to this if you or a member of staff from each business could attend the local parish council meeting at Jubilee Hall on Tuesday 16th April at 7pm. If you would please also bring with you a printed and signed copy of your letter addressed to Bishops Waltham Parish Council so that it can be handed to their representative present who will be acting on our behalf to H.C.C. If you are unable to attend the meeting on Tuesday I will be pleased to present your letter on your behalf if you could bring it in to me at the Post Office.

We need the support of as many of the businesses in our town to help support us in this motion. If you are unable to bring in a copy of your letter but would like your opinion to be heard you can email it to me at some so that I can print it for submission.

Alas a lot of the arguments just don't stand up to scrutiny, for example;

As well being an inconvenience, I and other businesses have concerns for the welfare of our employees having to walk the distance with heavy bags of waste taking into consideration the traffic situations, weather conditions and that of our staff not being covered by company insurance whilst off premises, we feel that it is not practical nor required.

We also feel that this bin area will be unsightly & a potentially smelly area outside of the Social Club, a potential invitation for vermin such as rats, with the possibility it may be used for fly tipping and to boot reduces much needed parking spaces in the town by 4 spaces.

Don't give them heavy bags, empty the bin more often or use a trolley.

It's not a big distance, literally 30 yards for some of them?

What traffic. it's a tiny lane, disabled people cross there from the car park.

Weather conditions, their bin is already outside?

Staff not insured, but again, they're already outside?

Unsightly and smelly, we'll manage it and clean it, bins should be locked so no smells, the bins are metal so no rats, fly tipping we'll clean it.

Parking spaces, yes it does reduce the car parking spaces by 4, but that's not a reason not to use it.

With regards to appealing to HCC, there's no point they legally can't permit them, they just can't. And the comments about it not being an issue, I remember HCC highways sending out letters about bins in the highway in BW over ten years ago, so I know that's not true.

Alas 100 reasons could be provided, at the end of the day you can't just put your property on someone else's land without permission then object when they ask you to remove it, you certainly can't dump your property in an actual carriageway, literally in the road, when there are specific laws against it, obstruction of the highway etc. Their only other option is storing their own waste on their premises until it's ready to be collected, which I'm sure is even less palatable.

So, we provided a bin store to help out, other councils are using anti-social behaviour orders against firms to force them to store their waste on their own premises, so we're really not the bad guys here, we are trying to help.

Alas managing your own waste is just an element of running a business, and it's just not reasonable to dump it in the street.

Correspondence - Surface Conditions on Winchester Road - for consideration

21st March 2024

For sometime now, I've been reporting problems to Hants Highways with the road outside and adjacent to my property between Battery Hill and Tangier Lane, caused by the poor road surface and drain issues which cause significant road noise and vibration to my property and those adjacent to mine.

I have this week logged three additional reports on the highways site under references 21730391, 21730392 and 21730393 as the problem (in three separate locations) is getting worse again.

I received within a few hours a standard holding reply and the next day a further holding reply stating that these issues are covered by planned works (without any details on what these planned works involve!)

I contacted Hants Highways by phone yesterday and asked for this information namely when were these planned works due to start and what work was involved. This was partially received within a few hours stating the works were due to start on the 19/5/24 under job ref 22321529 but not was happening. I have today asked for further details as I fear that these planned works will be a "road patch" rather than a proper investigation/ resurfacing or permanent repair/replacement of defects.

If BWPC have any further information on what these planned works involve I'd be grateful for an update, likewise if I do receive a reply providing the information I've requested, I will forward it on to you. Having checked the Highways planned road works database, unsurprisingly I can't find any details either under the reference I've been given or for this location. I'm sure the site only seems to cover works in the current financial year as anything post April doesn't seem to be on there.

Having reported this last year too I'll be disappointed if this has been pushed into the next FYE on purpose due to cost. This is not the first time issues along this section of road have been reported. As I've stated several times when writing to you previously, the whole stretch of Winchester Road from the Crown Pub to Winters Hill Road is appalling both in terms of road surface condition and drainage.

If you need any further information or counsellors want to visit the location with me to understand the issues, please do not hesitate to contact me.

15th April 2024

I recently submitted several reports via the HCC online website in my continuing backwards and forwards over a significant period of time with the council regarding vibration and noise caused by defects in the road surface and drains.

The latest report references are: 21730391, 21730392, 21730393

I received a holding reply for each one, and a further reply stating that the reports are covered by "planned works" on the 19/5 under job reference 22321529. Having asked for details (and only been given a date) I'd like confirmation of what this job entails. Is it a proper investigation and repair or further patching of the issue? If it is the latter, I doubt on the basis I keep having to report defects in the exact same places every so often, the problems causing the issue for residents along this stretch of road are not going to go away.

I would also refer you to the letter I received from the principal engineer on 20/12/22 (your ref 7112063) in which he states rather crassly the increased level of traffic and noise is the price we pay for increased mobility. I would suggest again that on the basis these reports are frequent that this has nothing to do with the level of traffic along the road, or noise (which is only excessive when heavy traffic hits these defects) but are in fact due entirely to the poor state of the road surface itself and not the level of traffic along it. I have offered several times for reps of HCC highways and indeed the parish council to come and visit me and see and feel for themselves the issues first hand. The fact no one seems to want to take me up on this offer speaks volumes.

I await a reply detailing what the planned works under reference 22321529 actually involve as soon as possible.

I'm going to try and come along to the parish council Annual meeting this week subject a few things I'm doing on the day. I have attended a meeting before and it was clear from sitting in to some of the agenda some years back now, how frustrated some councillors were with some of the delays on things that have been reported directly by BWPC to the various bodies responsible for them. But as I said back then, this isn't going away from my point of view. I have emailed and I believe spoken to Nick in the past. I must admit I find the whole process of reporting road defects frustrating and most of Winchester CC and Hants Highways staff at the upper echelons decidedly unhelpful. This is one of the reasons I wrote directly to the Sec State for Transport as I hadn't received any meaningful reply from the powers that be at either WCC or HCC to my concerns including the Chairs of both authorities or their subordinates, which is appalling. Unsurprisingly I received a reply from HCC literally within hours of me making contact with the DfT and also emails from Flick Drummond and someone in the DfT stating I would get a reply as a matter of urgency. I made it clear to Flick that it's beyond belief that I should have to write to the Sec of State for Transport, a person with more important national issues to deal with, in order to get a reply from these elected officials.

As I said previously to you, if all they are doing is replacing one of the three reports I've highlighted, which are roughly 100-200 feet apart, it isn't going to help much. I've made that quite clear to them too, that they are three separate and distinct locations and three separate faults and issues which collectively is a bigger issue as it's always the same places. Indeed today the problems / defects are more noticeable than ever. Another thing that frustrates me (in relation to reports on the station roundabout for example) is the fact you have a gang of workers turn up and do one job and yet leave another literally within line of sight of the one they are doing, which was reported at the same time. The rationale is that other reports are deemed less urgent. What is even worse is having a reply back telling me that the issues have been done either from their own websites or fix my street when clearly it has not. I now take photos of most reports (if I'm able without getting run over) and a follow up photo when I'm told it has been done.

I have not copied in Nick to my reply. But when I do get a response from Highways I will copy you in.
