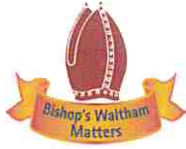

PH06/24 Public Session

A member of the public provided a very useful review on local bus transportation including an update from the 'Enhancement Partnership', which he is a representative of. A plan was noted for discussion on the 12th June to progress improvements suggested but this was felt must align with the Local Plan as well as sustainable and environmental considerations. The Chairman thanked the attendee for this continued awareness of the services and Cllr Williams added that the Parish Council had followed this line of response in the recent HCC Future Services Consultation.

A member of the public from Grovers Field highlighted concerns over the parked cars opposite the road entrance to the estate. It was acknowledged that WCC/HCC had been made aware of this previously but no action had been forthcoming.

ACTION: To report parked cars opposite Grovers Field to WCC/HCC ACTION: Executive Officer

A representative from Beeches Hill made a request for a change in the 'No HGVs' signage at the top and bottom of the hill and the speed limit sign relocated to lower on the hill. A request was also made for a pedestrians in the road sign. It was noted that current signage had been approved by HCC and any changes would need to be requested to them. It was reminded that agricultural vehicles had to use the road to access farmland so the width of the road was appropriate.

An update on the SID scheme was given in that new posts were being ordered to accommodate the new solar panels. Any data collected would be presented on the website and passed to the Police for information. The speed watch group was awaiting training from the Police Coordinator. Three traffic speed survey vans were noted to cover the whole of Hampshire and the Isle of Wight.

The bin store in the central car park was noted as an agenda item for the meeting. It was mentioned by the Chairman of the Chamber of Trade that the location was not the preferred one highlighted by the traders and the aim had been to tidy the bins, with appropriate wooden screening, not to reduce car parking spaces.

Cllr Latham and Cllr Williams were thanked for attending the recent WCC Planning Committee meeting in regard to a property planning application in Princes Close.

It was noted that the Parish Lengthsman role was being integrated into the Parish Council grounds team and therefore this agenda item would not be needed going forward. Any relevant issues regarding planning and highways, that fall under Parish Council responsibility, would be listed as an action for Parish Council ground staff.

Mrs Grover was not present but had sent a report stating that she was progressing two areas for tree protection orders to be placed and that the community hedge planting day had been very successful.

Footpath 31 - The Metlands Farm footpath was being monitored and if an application was to be made to reroute this path and not cross the farmyard then it was suggested to support this new route and to propose a kissing gate instead of the stile currently in place.

Footpath 40 – the bridleway at Pondsides/Montague Road was due for improvement by the Parish Council.

Footpath 28 – steps were in place on this pathway as the slope benefited from such but it was noted as not accessible for buggies and similar.

Footpath 42A – pathway being monitored. Planning Application for terracing at the site had been withdrawn.

Footpath 22 – Street End - new kissing gate to be installed with landowner's permission.

The kissing gates due for installation required a contractor to undertake such works.

1 Latest updates



Parish and Town Councils are now able to apply for 20mph speed limits and zones in residential areas, towns and villages throughout Hampshire. Residents with an interest in 20mph restrictions are advised to contact their local Parish or Town Council in the first instance.

A revised policy position for 20mph speed limits has been approved by the County Council that enables Parish and Town Councils, as well as other community groups, to request new 20mph speed limits and zones, where certain criteria are met, and where local communities are fully supportive of the measure. This revised approach will require schemes to be delivered on a full cost recovery basis meaning that Parish and Town Councils or community organisations will need to cover the full costs of any changes.

The revised policy position sets out the technical criteria that will need to be met to ensure that new 20mph schemes will be appropriate and adhered to by road users. This includes consideration of the strategic function of a particular road (for example, what type of traffic uses the road); likely driver/rider compliance to the proposed speed limit using existing data showing average mean speeds; the characteristics of the road and roadside environment; and the level of community support.

2 Self Assessment Guide

A self-assessment guide has been created to help Parish and Town Councils, and other groups, to evaluate the suitability of their requests against the technical criteria. The self-assessment process will also provide the County Council with the relevant information needed to evaluate the application.

Once completed, if the assessment indicates that the bid meets the criteria, it can be submitted to the County Council for consideration. There is a non-refundable £175 charge to cover this technical assessment.
