Right of Way Report for August 24

Footpath 43 stiles to kissing gates: Our two kissing gates have been installed at Tangier View Farm. The ground was very dry and hard but the contractors did an excellent job! I hope that the Ramblers will be installing the third gate, at Park Lug, very soon.





The side vegetation of the whole length of Footpath 43 from Albert Road has now been cut clear using a hedge trimmer.

Volunteers Meeting: We held a very successful meeting at the end of July when we discussed issues that each volunteer had met while checking paths. We decided that, now that there is reduced support from Countryside Services through lack of funds, we should have occasional working parties to clear some of the most overgrown paths. To start this off, we successfully tackled the **Bridleways 48 and 501** which link Little Ashton Lane and the top of Beeches Hill. The new recruit, who is able to work five Volunteer Days a year through his work company, then

came out with me and Robert on a separate occasion

to clear Footpath 1, Green Lane.


Footpath 12 and 5: Concern has been raised by a member of the public about the presence of horses in the field across which these two paths pass. The person thought that the horses are a danger to dogs. However, there are notices at either end of the paths to alert the public that the horses are either pregnant or young so dog owners are asked to keep their dogs under control. On checking, I found two of the horses



to be very friendly while the other four were quite disinterested. The Executive Officer has written a response to the concerned person as it would appear that the horses pose little danger. Footpath 12 is part of the Pilgrims Trail from Winchester to Porchester as well as The Alan King Way, however, so it is unfortunate if walkers are deterred from walking these paths.

A resident raised concern over the application to divert footpath 31. The committee noted the issues and suggested a meeting to be scheduled with the Hampshire Countryside Planning team to discuss such matters. The contact details of the Planning Officer were also provided.

A member of the public spoke in support of the skate ramp planning application 24/01270/FUL. Cllr Conduct requested the speed watch camera be available for the Parish Council stand at the Country Fayre on 21st September which the committee agreed to.

The Executive Officer informed the committee of correspondence regarding concerns over speeding traffic on the B2177. Advice on reporting such to the police was given to the resident



and the speed indicator device would be positioned at Churchill Avenue by Autumn to raise speed awareness in that area.

Cllr Williams updated the committee with news that the public toilets facility in the central car park was due to be refurbished in Autumn 2024, including liaison with the Parish Council in terms of design.

It was noted that a resident had submitted a nomination for Bishop's Waltham in the annual Best Village in Hampshire competition. Councillors and residents would be encouraged to support this nomination during the judging visit next Tuesday morning.

The Executive Officer provided an update on the Albany Wood open space works by the developer and noted concerns about the quality of soil which was being closely monitored by the Parish Council and Winchester City Council officers.

Report from Tree Warden: This is a substantial tree with a protection order on it. It is a beautiful, heritage tree. The house is on a large plot having a long wide driveway. With the electric gates quite some way along the drive away from the road. There is ample room to move the pillars supporting the electric gates, away from the tree. The wall alongside the tree cannot be moved as it is a boundary wall. However, it is likely that the roots have damaged the wall foundations. It is not the actual trunk causing damage as this is away from the wall. Small cracks can be seen on the pillar, but I did not observe damage to the wall.

Dear Madam and Sir.

Your new Labour government have been clear that, through the implementation of the new Planning and Infrastructure Bill, they aim to be "builders not blockers", but this presents us with some concerns that are outlined below.

Bishop's Waltham is the biggest town in the Meon Valley in Southern Hampshire and is within the Winchester District Council area. We also have an active High Street which serves the surrounding area and a busy road, the B2177, which the town straddles.

A Town Design Statement was produced in 2016 and adopted by Winchester District Council as part of the Planning Policies. We are also bordered to the north by the South Downs National Park.

As a Parish Council that has been involved in the process of adding 500 new homes to our large village of approximately 7000 people, there are actions that can make additional homes a positive experience for all concerned. We would like these actions to be part of the plans for change in the new National Planning Policy Framework (NPPF)

With the need to accommodate a consistent growth year on year, this has resulted in the construction of five new developments in Bishop's Waltham in the last six years, and they have all been located on the south side of the village as we are unable to extend northwards due to the National Park boundary.

Consequently, they have all increased the traffic on our already busy and failing roads. There are actions that were taken with infrastructure which alleviated some aspects of the new housing. i.e. our infant and junior school had an extra classroom built in each year group, so there are no problems with school places for our new children.

However, other infrastructure issues have caused problems.

- Road junctions have not been well planned for some developments, and the majority have been completed with no improvement to the existing highway infrastructure, which is essential to accommodate the increased volume of traffic, as well as maintaining the safety of both drivers and pedestrians.
- The inability to build to the north of the town centre due to the South Downs restrictions on building has led to one big estate being too far from the shops to walk in 15 minutes, which has increased parking problems in the town centre and surrounding housing areas.
- The doctors' surgery building has not grown enough for the increased population so we need to have portacabins until a new appropriate building can be built.
- Also, the type of housing provided on the new developments have not always had the desired 40% of affordable housing. Some properties marketed as "2 bedroom / affordable" are attracting starting prices from £550k, which is beyond the reach of local families wishing to remain in the town.

In conclusion, while we support the need for the national additional housing targets, we urge you to please develop the infrastructure first before building and listen to the people who live in the area before imposing new housing targets. Winchester City Council have been very good at asking the residents of Bishop's Waltham what is needed, and it is important to use local knowledge to get the right type of houses, that are in-keeping with the surroundings, and in the correct locations to suit the local plan.

A letter has been sent to Winchester City Council requesting the Planning Team visit Bishops Waltham and review the existing infrastructure, and the new estates recently completed, with a focus on the cumulative positive and negative aspects. The points arising can then be further considered for future estates when planning applications are proposed for Bishop's Waltham.

On 12th August 2024, the Executive Officer, Councillor Williams, and I met the final landowner along the BW-Swanmore route to discuss the proposals from Hampshire Countryside Services, and to confirm dedication of the footpath for the project.

The meeting went very well with the landowner being very supportive and verbally agreeing to the dedication of their section as bridleway, which is the next step required from Hampshire's perspective. There remain some technical decisions regarding placement of fences, gates, etc. but none are show-stoppers and they will be dealt with in due course.

The next steps are to collate all of the dedication agreements in writing and begin to seek funding. BWPC will also approach another landowner to ask if a portion of the path could go across the edge of their land, as this would be slightly easier than the original route for widening.

We will bring any matters for consideration to the Committee/Council as and when required.
