

#### Right of Way Report for March 25

Footpath 5 and 12: A meeting between the landowner, Officer, Indiana and the HCC Rights of Way Officer, had been arranged for 18 <sup>th</sup> March to resolve ongoing issues that had been raised by members of the public objecting to erection of fences and stiles to contain the landowner's horses. HCC consider these as "wilful obstructions" under the Highways Authority. Unfortunately, the HCC Rights of Way Officer, was held up at a previous meeting and did not turn up. A new meeting has been arranged for 2 <sup>nd</sup> April.
Our Path Volunteers have responded promptly to recent requests from, our Engagement Officer, to check on outstanding issues of fallen trees across three of our Rights of Way. These were cleared and reports sent.
Councillor Mike Homer reported extremely muddy surface conditions on Footpaths 39 and 50. The landowner of Footpath 50 has narrowed the access to the gate on the boundary of his land which has led to muddier conditions in winter over the last few years. I recommend that the landowner is asked to improve the surface with hardcore or gravel. Conditions on all paths are beginning to improve with the dryer weather.
I have arranged to hold a meeting on 31 <sup>st</sup> March for our Footpath volunteers to work out how the group should continue after I have stepped down as Rights of Way Warden. Two have volunteered to help with some organising and I am meeting them first as they are both unable to make the meeting on 31 <sup>st</sup> .

The Committee were investigating the damaged bus shelter opposite Sainsburys Garage on the B2177 (Pondside) and considering the removal and replacement thereof.

Since this matter has arisen, contact has been made with the office by the Local Bus Project Officer at HCC.

HCC have draft bus stop improvement plans for Bishop's Waltham which aims to update bus stop infrastructure as well as some access improvement works (Cricklemede and North Pond). Drawings are due to be shared with us when approved and made public.

HCC have agreed with the proposal to consult with the public regarding the proposed removal of the Pondside bus shelter (due to being damaged twice) and the replacement of this shelter with a bus stop pole, at HCC cost.

Bishop's Waltham In Bloom have asked for assistance in applying for the renewal of their licence (last approved in June 2020). The Parish Council is a permissible body to apply for the licence under section 96 and 142 of the Highways Act 1980.

The office has been in contact with HCC about the changes in the licence application form and is working with BWIB representative on progressing this for community benefit.

The basic cost is £209.50 for three years (but may cost more as this is based on 5 locations and BWIB may have more than this).
